

Agreement between NTP Media, Inc. and \_\_\_\_\_, the "hosting website."

**CM e-News Daily™** is part of the CM B2B Trade Group™ (CM B2B), a division of NTP Media, Inc. (NTP), and grants to the hosting website the limited right to use and display its registered trademark **CM e-News Daily™** only in the "headline news box" which is being provided by NTP to the hosting website to be displayed on its website.

The hosting website and its owners and managers agree not to permit the use of the **CM e-News Daily™** trademark in any other location or in any other manner in or on any electronic or print publication or media without obtaining prior permission in writing from NTP to do so.

The hosting website and its owners and management agree to abide by this limitation on the use of **CM e-News Daily™** trademark.

The hosting website and its owners and management acknowledge and agree that the CM B2B and NTP will have exclusive control over the content and the headlines in the "headline news box" on the hosting website, and the owners and management of the hosting website agree not to attempt to make any changes to the content or the appearance of the "headline news box" provided by NTP.

If the managers and owners of the hosting website faithfully adhere to the provisions of this agreement, NTP will assume all liabilities for and hold the hosting website harmless for any damage claims specifically regarding and related to the content and information contained in the "headline news box" provided by NTP.

If the managers and owners of the hosting website make any changes to the "headline news box" or violate the provisions of this agreement in any way, NTP's agreement to assume all liabilities for and to hold the hosting website harmless for any damage claims regarding the content and information contained in the "headline news box" provided by NTP are automatically withdrawn and will be voided by such actions by the hosting website.

The hosting website can remove the "headline news box" from its website at any time without giving prior notice to the CM B2B. If the "headline news box" is removed from its website for more than five consecutive business days, the hosting website agrees to notify the CM B2B of such removal, and the hosting website agrees to notify the CM B2B of reinstatement of the "headline news box" if it is reactivated after such a removal. The hosting website acknowledges and understands that the CM B2B cannot provide customized versions of daily headlines for websites hosting the "headline news box."

The hosting website also acknowledges, understands and accepts the inherent risks in the fact that content of **CM e-News Daily™** stories is drawn from company, government and association news releases, daily and weekly newspapers, various websites, news services, court records, government decisions and records, financial reports on file at government agencies, public statements by government and corporate officials and other publicly available sources, and as such, some headlines fed to the **CM e-News Daily™** "headline news box" on the hosting website may not be deemed appropriate for the hosting website because the headlines may report on news:

- about competitors of the hosting website,
- about topics the management of the hosting website does not consider beneficial to the mission of its website about stories that do not necessarily reflect positively on the hosting website's sponsors.
